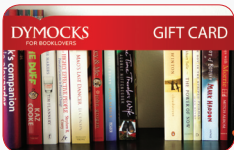

1. Instructions of how to claim form part of these terms and conditions. MHIAA account holders are ineligible to enter. **3.** The "Promotion Period" commences at 9:00 am 11th of April 2011 and final claims close at 11:59 pm (AEST) on 31st August 2011 or when stocks of the "Participating Product" are no longer available, or 4,000 compliant claims have been received or whichever comes first. **4.** The Promoter is Mitsubishi Heavy Industries Air-conditioners Australia Pty Ltd.
